

NOTICE IS HEREBY GIVEN for following change to the Scheme Information Document (SID) and Key Information Memorandum (KIM) Quantum Multi Asset Fund of Funds.

Change in Product Labeling - Risk-o-meter - of Quantum Multi Asset Fund of Funds.

Investors / Unitholders are requested to note that in accordance with SEBI circular No. SEBI/HO/IMD/DF3/CIR/P/2020/197, dated October 05, 2020, risk-o-meter of Quantum Multi Asset Fund of Funds has been revised based on the scheme's portfolio as on October 31, 2021 as follows:

The reason for change in the Risk-o-Meter is that within debt allocation, the fund marginally increased its exposure to higher risk segment of long-term debt through the Dynamic Bond fund. This was done as normalization of monetary policy by the RBI has been pushed down the road which is keeping the yield differential between short term debt and long-term debt elevated. The fund's allocation to gold, which comes with higher risk, also increased in the month of October 2021, on account of both price appreciation as well as increased allocation to bring the weight closer to optimal allocation as per our asset allocation framework.

This addendum forms an integral part of the Scheme Information Document (SID) /Key Information Memorandum (KIM) of Quantum Multi Asset Fund of Funds as amended from time to time.

All other terms and conditions as mentioned in the SID & KIM of the Quantum Multi Asset Fund of Funds shall remain unchanged.
