NOTICE IS HEREBY GIVEN for following change to the Scheme Information Document and Key Information Memorandum of Quantum Liquid Fund.

Change in Product Labeling - Risk-o-meter - of Quantum Liquid Fund.

Investors / Unitholders are requested to note that in accordance with SEBI circular No. SEBI/HO/IMD/DF3/CIR/P/2020/197, dated October 05, 2020, risk-o-meter of Quantum Liquid Fund has been revised based on the scheme's portfolio as on July 31, 2022 as follows:

During the month, Quantum Liquid Fund has invested 4.91% of net assets in a certificate of deposit (CD) of Public Sector Bank. Rating of the certificate of deposit is "A1+" which is top notch for short term debt instrument. The long debt instruments have credit rating of "AAA" from CRISIL, CARE and Brickwork; however, India Rating has assigned a credit rating of "AA+" to the long term debt instruments of the same PSU Bank. Given the most conservative long term credit rating of "AA+", the credit risk and liquidity risk scores for the portfolio has increased marginally above 1. This has led to change in the Risk-o-Meter of the scheme to "Low to Moderate Risk" from "Low Risk".

This addendum forms an integral part of the Scheme Information Document (SID) /Key Information Memorandum (KIM) of Quantum Liquid Fund as amended from time to time.

All other terms and conditions as mentioned in the SID & KIM of the Quantum Liquid Fund shall remain unchanged.
