Can the first unit holder name be deleted/changed?

No. The first unit holder's name in a folio cannot be deleted. Addition / deletion of holders is allowed in any case whether it is single, joint or any one or survivor. Deletion of first Unit Holder name (in respect of any mode of holding) is allowed only in case of transmission.

Is addition / deletion of holders allowed in case the unit is subject to lien / charged / pledged?

No. In case of the units is subject to lien / charge / pledged, request for addition / deletion of joint holders will not be accepted.

What are the documents required For Addition of holders?

Below given is the list of documents for addition of holders.

- Duly filled and signed form(s) for addition of holders
- Acknowledgement / declaration from proposed joint holders
- KYC Acknowledgement Letter / KYC Application form with prescribed documents of proposed joint holders
- Duly filled and signed FATCA form

What are the documents required For Deletion of holders?

Below given is the list of documents for deletion of holders except First Holder.

- Duly filled and signed form(s) for deletion of holders
- Declaration of existing holders
- In case of death of any unit holder, the surviving joint holder(s) have to follow the transmission procedure on the name of the surviving joint holder(s)

Will any stamp duty be required to be paid on the Form and Declaration?

Yes, each Form with declaration depending upon the type of request needs to be stamped by way of franking amounting to Rs. 300/-.

How much time will it take to process my request for addition / deletion of holders?

The request for addition / deletion of holders will get processed within 10 working days (subject to verification /validity of documents) post which you will receive a confirmation mail / letter with regard to registration / rejection of your request.

What will be my mode of holding for the folio?

In case of deletion of all holders in a folio other than the first holder the mode of holding will be registered as 'Single'.

For other scenarios, the investor has to select the respective option viz 1.Joint 2.Anyone or Survivor for mode of holding in the form.

Do I need to submit a request for Nominee registration also?

Yes. A fresh nomination form duly signed by the existing holder and proposed Joint holders to be submitted along with the request.

How many holders can be added in the folio?

Maximum two joint holders can be registered in a folio, such that there are total number of three holders in the folio.

Can a minor be added as a joint holder?

No. As per AMFI guidelines, "The minor shall be the first and the sole holder in a Folio. Minor investor cannot be a joint holder in a folio.
