## NOTICE OF CHANGE IN TOTAL EXPENSE RATIO OF THE SCHEMES OF QUANTUM MUTUAL FUND

Notice is hereby given that the Total Expense Ratio ("TER") (i.e. TER excluding additional expenses provided in Regulation 52(6A)(b) and 52(6A)(c) of SEBI (Mutual Funds) Regulations, 1996 and Goods and Services Tax on Management Fees) for the following Scheme(s) of Quantum Mutual Fund ("the Fund") shall be revised with effect from April 1, 2023.

In order to align with Indian Account Standard requirement regarding transactions cost of investment to be expensed out (viz. to be charged to Revenue Account instead of Capitalisation) and as per the amended SEBI Regulations 52 (6A)(a) of MF Regulations, any payment towards brokerage & transaction costs, over and above the 12 bps for cash market transactions is to be charged to the Scheme within the maximum limit of Total Expense Ratio (TER) effective 1st April, 2023. Accordingly, Investors may please take note that, the change in the TER is on account of change in the accounting treatment of Brokerage & Transaction Cost over & above 12 bps which is required to be charged to the Scheme within the maximum limit of Total Expense Ratio (TER) effective from April 1,2023. However, due to change in accounting treatment there would not be any material impact on the NAV.
